3. **RECONNECTION (delinquent)** - \$40.00 per Commission Rule A.A.C. R.14-2-403(D)(1)
4. **NSF CHECK** - \$15.00 per Commission Rule A.A.C. R14-2-409
5. **METER RE-READ (if correct)** - \$10.00 per Commission Rule A.A.C. R14-2-408(C)(2)
6. **METER TEST (if correct)** - \$10.00 per Commission Rule A.A.C. R14-2-408(F)(1)
7. **DEFERRED PAYMENT** - 15.00% per annum per Commission Rule A.A.C. R14-2-409(G)(6)
8. **DEPOSIT INTEREST** - Per Commission Rule A.A.C. R14-2-403(B)(3)
9. **DEPOSIT** - Per Commission Rule A.A.C. R14-2-403(B)(7)
10. **RE-ESTABLISHMENT (within 12 months)** - Months off the system times the minimum per Commission Rule A.A.C. R14-2-403(D)(1)

ADJUSTMENT: Plus the applicable proportionate part of any taxes or governmental impositions which are or may in the future be assessed on the basis of the gross revenues of the Company and/or the price or revenue from the water or service sold and/or the volume of water pumped or purchased for sale and/or sold hereunder and any tax or similar assessment based on the withdrawal, delivery or use of water. In the event of any increase or decrease in taxes or other governmental impositions, rates shall be adjusted to reflect such increase or decrease.
