NOTICE OF RATE CHANGE - Pinal Valley

W-01445A-19-0278/W-01445A-18-0400

On December 13, 2019, Arizona Water Company filed an application with the Arizona Corporation Commission for the approval of permanent adjustments to the rates and charges for water service provided by the Company's Western Group of water systems. Based on the rates authorized in Docket Nos. W-01445A-19-0278 and W-01445A-18-0400, a monthly bill for the residential customer in the Pinal Valley system with a 3/4" x 3/4" meter and average usage of 7,100 gallons per month will increase from \$38.27 to \$47.37, an increase of \$9.10 per month or 23.78% percent. The new rates were effective on April 1, 2021, for Arizona Water Company's Pinal Valley system.

Guarantee Deposit	Residential – maximum: Two (2) times average customer class bill. Non-Residential – maximum: Two and one-half (2½) times that customer's estimated maximum monthly bill.
Reconnection for Delinquency	\$32.00, each time customer is disconnected.
Re-Establishment	Eight (8) times the customer's monthly minimum charge, or payment of the minimums since disconnection, whichever is less.
After Hours Service Charge	\$35.00, each service call-out after regular working hours, on Saturdays, on Sundays or holidays when such service is at the request of the customer.
Returned Payments	\$25.00, each returned payment for insufficient funds.
Meter Re-read	\$25.00 – all meter re-reads
Meter Test	No charge for the first test; for the second test for the same customer within any twelve (12) month period, \$25.00, or actual time and material, whichever is greater.
Late Charge	1.5 percent after 15 days.
