



## Arizona Water Company Toilet Rebate Program – Kohler Expansion

The Arizona Water Company (AWC) Single-Family Residential High-Efficiency Toilet Rebate program provides an incentive for upgrading old toilets to new high efficiency Environmental Protection Agency (EPA) [Water Sense-labeled toilets](#)<sup>1</sup> to conserve water.

Thanks to a partnership with Kohler Company, this rebate program is expanding for Arizona Water Company customers in Pinal Valley, which includes the cities of Casa Grande and Coolidge, and surrounding areas. As of February 18<sup>th</sup>, 2025, Arizona Water Company and Kohler Company are offering rebates for the full cost of select, high-efficiency Kohler toilets, with an additional rebate available of up to \$100 towards the cost of a licensed contractor to install the toilet. No rebate will exceed the cost of one of the select Kohler toilets plus \$100 for installation costs.

The following Kohler toilet models are eligible for the expanded Toilet Rebate Program:

- Highline 1.0 gallons per flush (gpf) (*Up to \$340.72*)

### **PROGRAM ELIGIBILITY (AT A GLANCE)**

- A.** Applicant must abide by the Rebate Universal Terms and Conditions (see page 6 and 7)
- B.** Only single-family residential properties that are privately maintained and have a dedicated water meter qualify. Multi-family properties and master-metered properties do not qualify.
- C.** Applicant must be the owner of the property where the new toilet is being installed or must have written permission for the owner. Form available upon request.
- D.** Only one toilet per property is applicable for the rebate.
- E.** New construction or additions do not qualify.
- F.** Applications must be submitted within six (6) months of the purchase and installation of an eligible toilet. A toilet purchased and/or installed before August 18<sup>th</sup>, 2024 is not eligible for the rebate, unless otherwise approved by AWC staff.

## Arizona Water Company Toilet Rebate Program – Kohler Expansion

**G.** Rebate applications must be submitted and received by AWC by May 29th, 2026 or until funds are exhausted, whichever is earlier.

**H.** The following evidence must be provided as part of the application:

- Copy of the toilet purchase receipt as proof of purchase. Copy of the toilet installation invoice or receipt as proof of installation. Installations need to be conducted by a licensed contractor to qualify for this portion of the rebate.
- Itemized receipts must show the total amount paid, subtotal cost before tax, the date purchased, and the business purchased from. Discounts towards the purchase price will be subtracted from the amount eligible for rebate. Taxes and shipping costs are not eligible for rebate. The amount of a rebate cannot exceed the amount paid.
- A photo or photos showing the old toilet, and a photo or photos showing the new toilet after it has been installed.

- Itemized receipts must show the total amount paid, subtotal cost before tax, the date purchased, and the business purchased from. Discounts towards the purchase price will be subtracted from the amount eligible for rebate. Taxes and shipping costs are not eligible for rebate. The amount of a rebate cannot exceed the amount paid.
- A photo or photos showing the old toilet.

## Arizona Water Company Rebate Terms and Conditions

Effective June 1<sup>st</sup>, 2024

Last updated: February 11<sup>th</sup>, 2025

### Rebate Universal Terms and Conditions

- A. Rebates are available to active Arizona Water Company customers only. The installation address must be within the Arizona Water Company (AWC) Certificate of Convenience and Necessity (CCN) service areas.
- B. Applicant must be the owner of the property or have the written permission of the owner to implement the specific conversion or efficiency upgrade and to apply for and receive rebate funds. Form available upon request.
- C. A limited number of rebates are available each year. Rebates will be given on a first come, first serve basis based on the date and time AWC receives the rebate application.
- D. AWC reserves the right to change, update, or suspend programs at any time.
- E. New construction or additions to homes do not qualify.
- F. Inspection of the property may be required to verify installation or conversion.
- G. Any photos submitted are the property of AWC and may be shared in AWC reports and promotional materials.
- H. Itemized receipts must show the total amount paid, subtotal cost before tax, the date purchased, and the business purchased from. Discounts towards the purchase price will be subtracted from the amount eligible for rebate. Taxes and shipping costs are not eligible for rebate. The amount of a rebate cannot exceed the amount paid.
- I. The rebate will be provided to AWC customers as a check mailed within 6-8 weeks of AWC approving the application, unless otherwise specified.

### Single-Family Residential High-Efficiency Toilet Rebate

**Purpose of rebate:** This rebate provides an incentive for all qualifying AWC customers to upgrade inefficient toilets to efficient Environmental Protection Agency (EPA) [WaterSense-labeled toilets](#) to conserve water.

- A. Applicant must also abide by the Universal Terms and Conditions.
- B. Toilet purchased and installed must be an EPA [WaterSense-labeled toilet](#) that flushes 1.28 gallons per flush (GPF) or less, or a dual flush toilet which uses no more than 1.6 GPF at maximum.
- C. Only single-family residential properties that are privately maintained and have a dedicated water meter qualify. Multi-family properties and master-metered properties do not qualify.
- D. Rebate explanation:
  - a. Applicants may receive a rebate up to \$100 toward the purchase of an EPA

WaterSense-labeled toilet and a rebate of up to \$100 toward the cost of a licensed contractor to install the toilet. No rebate will exceed \$200.

b. If you have questions regarding this explanation, call 602-294-2479. This line goes straight to voicemail. The water conservation team checks messages daily and respond within 2-3 business days.

- E. Only one toilet per property is applicable for the rebate. If you are new to the house or unsure of your eligibility, please contact the Water Conservation team by calling 602-294-2479, or by emailing [savewater@azwater.com](mailto:savewater@azwater.com) prior to submitting the rebate form to determine if your home qualifies.
- F. Applications must be submitted within six (6) months of the purchase and installation of an eligible toilet. A toilet purchased and/or installed before January 1st, 2024 is not eligible for the rebate.
- G. Rebate applications must be submitted and received by AWC by May 29th, 2026 or until funds are exhausted, whichever is earlier.
- H. The application must include a copy of the toilet purchase receipt as proof of purchase. The application must also include a copy of the toilet installation invoice or receipt as proof of installation. Installations need to be conducted by a licensed contractor to qualify for this portion of the rebate. Applications submitted without receipts will not be processed.
- I. To qualify for this rebate, the application must include a photo or photos showing the old toilet, and a photo or photos showing the new toilet after it has been installed.

### Kohler Company Toilet Rebate Expansion

**Purpose of rebate:** AWC is partnering with Kohler Company to expand the Toilet Rebate Program for AWC customers in Pinal Valley, which includes the cities of Casa Grande and Coolidge, and surrounding areas. Under this expansion, customers can get a rebate for the full price of a select Kohler toilet, as follows.

- A. The rebate is effective February 18<sup>th</sup>, 2025 for AWC customers in the Cities of Casa Grande, Coolidge, and surrounding areas.
- B. Applicant must also abide by the Rebate Universal Terms and Conditions.
- C. The customer must purchase and install one of these four select Kohler toilets:
  - o Highline 1.0 gallons per flush gpf (*Up to \$340.72*)
    - Model number: K-5298-RA

  - o Highline Arc 1.28 gpf (*Up to \$199.00*)

- a. In addition to receiving \$100 toward the purchase of a toilet from AWC, customers may also receive, from Kohler, a rebate to cover the remaining cost of one of the Kohler toilets listed above. Customers can also receive the \$100 rebate towards the installation of the toilet with a licensed contractor.
- b. If you have questions regarding this explanation, call 602-294-2479. This line goes straight to voicemail. The water conservation team checks messages daily and will respond within 2-3 business days.
- E. Only single-family residential properties that are privately maintained and have a dedicated water meter qualify. Multi-family properties and master-metered properties do not qualify.
- F. The expanded rebate is available for only one toilet per property. If you are new to the house or unsure of your eligibility, please contact the Water Conservation team by calling 602-294-2479, or by emailing [savewater@azwater.com](mailto:savewater@azwater.com) prior to submitting the rebate form to determine if your home qualifies.
- G. Applications must be submitted within six (6) months of the purchase and installation of an eligible Kohler toilet. A toilet purchased and/or installed before August 18th, 2024 is not eligible for the rebate.
- H. Rebate applications must be submitted and received by AWC by May 29<sup>th</sup>, 2026 or before funds are exhausted, whichever is earlier.
- I. The application must include a copy of the toilet purchase receipt as proof of purchase. The application must also include a copy of the toilet installation invoice or receipt as proof of installation. Installations need to be conducted by a licensed contractor to qualify for this portion of the rebate. Applications submitted without receipts will not be processed.
- J. To qualify for this rebate, the application must include a photo or photos showing the old toilet, and a photo or photos showing the new toilet after it has been installed.
